Dear Mr. Tillotson:

This is in reference to the request filed on August 8, 2013. EKO requests further extension of the STA originally granted on September 18, 1998, for operation of Station WRJE with reduced power and a non-directional antenna.¹ In support of the request, EKO states that an FCC Form 301 application to change site will be filed after negotiations for the new site have been completed.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WRJE may continue to operate at its licensed site with reduced power not to exceed 1.25 kilowatts daytime and 0.25 kilowatt nighttime (non-directional). It will be necessary to further reduce power or cease operation if complaints of interference are received. EKO must use whatever

¹ WRJE is licensed for directional operation on 1600 kHz with 5 kW day and 1 kW night.

means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 30, 2014**. Failure to file an FCC Form 301 application or to submit an updated detailed text justification (with new info as to what steps the licensee has taken towards restoring licensed operation) before the expiration date shown above may lead to a denial of any further extension and cancellation of the original STA.
