Dear Counsel:

This is in reference to the request filed October 24, 2013, on behalf of Oregon Public Broadcasting ("OPB"). OPB requests an eighth extension of the special temporary authority ("STA") granted on May 12, 2009, to operate FM Translator Station K219FJ with temporary facilities.<sup>1</sup> OPB holds construction permit BPFT-20121101AAT (expires July 18, 2016), but a condition on that construction permit precludes K219FJ from commencing operation on Channel 203 until KYAQ commences operation on Channel 219.<sup>2</sup> The STA will permit continued operations by K219FJ pending KYAQ's completion of construction.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

<sup>1</sup> K219FJ is licensed for operation on Channel 219D (91.7 MHz) with effective radiated power of 0.205 kilowatt (H&V) and antenna height above average terrain of 20 meters.

<sup>2</sup> KYAQ, Siletz, OR (Facility ID No. 171967) holds construction permit BMPED-20130813ACD for operations on Channel 219A. This construction permit expires January 4, 2014.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its. Thus, extension of STA is warranted.


Accordingly, the request for extension of STA IS HEREBY GRANTED. Station K219FJ may continue to operate with the following facilities:

Channel	219 (91.7 MHz)
Effective radiated power:	0.012 kilowatt (H&V)
Antenna height:	
above average terrain:	-1 meters
above mean sea level:	96 meters
above ground:	9 meters

OPB must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **May 4, 2014**.
