RE: Withdrawal of Applications; Refiling; Transfer of Filing Fee

Dear Mr. Robbins:

Sierra Communications Company, Inc., and Ruby Mountain Broadcasting Company, Inc., the respective licensees of Stations KRNV-DT, Reno, Nevada [Facility ID 60307] and KENV-DT, Elko, Nevada [Facility ID 63845], through their counsel, respectfully request the Commission dismiss the short-form applications seeking the transfer of control of the respective licensees. When these applications were filed they mistakenly identified them as seeking permission for transfers of control when the actual intent was to seek approval on an intra-corporate an assignment the respective licenses. Concurrently herewith this request for dismissal we are submitting new applications on FCC Form 316 seeking the *pro forma* assignments of the respective licenses from corporate entities to limited liability entities. The original licensees, stations and application file numbers are as follows:

Although these applications were amended on November 13, 2013 to request that they be processed as assignments as opposed to transfers, the FCC's CDBS system apparently does not permit this kind of modification. Accordingly, in order to allow the system to generate certificates recognizing that these ownership changes are assignments instead of transfers, we are requesting dismissal of the original transfer of control applications and substituting assignment applications. These new *pro forma* assignments will be filed today after the LPFM filing deadline expires at 3:00 p.m. EDT.


