Dear Mr. Benedict:

This is in reference to the request filed November 15, 2013, on behalf of CBS Radio Stations, Inc. ("CBS"). CBS requests an extension of the special temporary authority ("STA") granted on August 5, 2013, to operate Station KXNT-FM with temporary facilities while the licensed main antenna is modified to reduce downward radiation and potential radiofrequency exposure at the transmitter site. The main antenna must be off the air to perform the work. Operation from the temporary site will maintain station operation.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


We conclude that extension of the STA is warranted. Accordingly, KXNT-FM may operate with the following facilities:

Geographic coordinates:	36° 56' 01" N, 115° 03' 01" W (NAD 1927)
Channel	263 (100.5 MHz)
Effective radiated power:	5.6 kilowatts (V only)
Antenna height:	
above ground:	32 meters
above mean sea level:	1255 meters
above average terrain:	459 meters

CBS must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. CBS must notify the Commission when licensed operations resume. Changes to the licensed antenna system may require the filing of FCC Form 302-FM to update the current station license.

This authority expires on May 25, 2014.
