Dear Ms. Dortch:

On behalf of the Idaho State Board of Education (Boise State University), licensee of noncommercial educational radio Station KBSY(FM), Burley, Idaho, we hereby inform the Commission that KBSY(FM) has resumed full power, licensed operation following a brief period of reduced power operation.

Boise State University previously notified the Commission by letter dated October 30, 2013 of KBSY(FM)'s temporary reduced power status due to technical issues. Boise State University now notifies the Commission that KBSY(FM) has addressed the issues and restored full power operation.

The licensee is a noncommercial educational licensee and operates KBSY(FM) on a noncommercial educational basis. Moreover, the licensee qualifies as a governmental entity. The licensee is therefore exempt from FCC filing fee and regulatory fee requirements for KBSY(FM), pursuant to Sections 1.1116 and 1.1162 of the Commission's rules. Dear Ms. Dortch:

On behalf of the Idaho State Board of Education (Boise State University), and pursuant to Section 73.1560(d) of the Commission's Rules, we hereby notify the Commission of the temporary reduced power operation of noncommercial educational radio Station KBSY(FM), Burley, Idaho due to technical issues.

Station KBSY has been operating at approximately 25% of its authorized power level since October 21, 2013 due to a transmitter malfunction. The licensee is currently working towards repair of the KBSY facilities. The licensee will file separately for Special Temporary Authorization if it becomes necessary to maintain the reduced power status for thirty or more days.

The Idaho State Board of Education (Boise State University) is a noncommercial educational licensee and operates KBSY(FM) on a noncommercial educational basis. Moreover, the licensee qualifies as a governmental entity.
