On behalf of Educational Media Foundation ("EMF"), permittee of noncommercial educational station WVRI(FM), Pavo, Georgia, and applicant for a license to cover the construction permit of the station in the above-referenced application, this letter is to request reinstatement of Automatic Program Test Authority.

On August 10, 2005, EMF requested that the Commission delay the grant of EMF's pending request for reinstatement of Automatic Program Test Authority. EMF notified the Commission that on August 8, 2005, during the performance of equipment tests, the plate transformer in the transmitter failed; and that EMF would order replacement parts, promptly install them and recommence tests upon receipt. EMF has made the necessary repairs and the station is currently fully operational. Accordingly, EMF respectfully requests that the Commission grant reinstatement of Automatic Program Test Authority.
