In support of this Motion, SBCCD states:



2. SBCCD's concerns regarding interference by KCWQ-LD to the input reception of its television translator station KJHP-LP of SBCCD's full-power primary station, KVCR-DT, San Bernardino, CA, have been resolved by way of alternate delivery of the KVCR-DT input.

3. As confirmed in the attached Declaration, no compensation has been provided or promised in exchange for the instant Motion to Withdraw.

4. In light of the foregoing, SBCCD withdraws all now-pending objections (and related pleadings) to KCWQ-LD, Palm Springs, CA (Facility Id. No. 167761), and requests the Commission give them no further consideration.
