This is in reference to: 1) your letter dated November 19, 2002, filed on behalf of Buchanan Broadcasting Co., Inc. (Buchanan), requesting extension of the special temporary authority (STA) granted August 23, 2002, to operate Station WJNT with reduced power during critical hours; and 2) your letter of December 13, 2002, which notifies the Commission that Station WJNT has restored licensed operation and that STA is no longer needed.¹


Dear Ms. Dortch:

This letter is written on behalf of Buchanan Broadcasting Co., Inc. ("Buchanan") pursuant to Section 73.1560(d) of the Commission's rules in order to advise the Commission that on December 11 Buchanan completed installation of its new Nautel transmitters and resumed licensed operations.

We respectfully note that on November 19, 2002 this office filed a request for further special temporary authority in order to afford Buchanan an opportunity to continue operating with nighttime power during critical hours pending installation of a replacement transmitter to permit licensed operation. At that time, the transmitter had not yet been shipped, even though it had been ordered several months earlier. Accordingly, now that licensed operations have resumed, an extension of special temporary authority, as requested in our November 19 letter, is no longer needed (although Buchanan does require an extension of its previous special temporary authority through December 11, 2002, when licensed operations were restored).

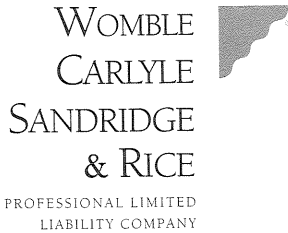

Request for Further Special Temporary Authority**

Dear Ms. Dortch:

This letter is written on behalf of Buchanan Broadcasting Co., Inc. ("Buchanan") pursuant to Sections 73.1560(d) and 73.1635 of the Commission's rules in order to request further special temporary authority ("STA") for station WJNT (AM), Pearl, Mississippi to continue operating with reduced power during critical hours pending replacement of its transmitter.


This office had advised the Commission by letter of July 16 that WJNT's transmitter had failed on Tuesday, July 9. Buchanan had attempted to effect repairs which would have permitted operation at the full 10 kilowatts of authorized critical hours power, but parts proved difficult to obtain, as the manufacturer is no longer in business. On August 9, 2002 this office requested STA to permit critical hours operation at the same 500 watt level authorized for nighttime operation pending purchase and installation of a replacement transmitter that would permit critical hours operation at the full authorized level of 10,000 watts. FCC staff granted the STA by letter of August 23, 2002, to expire November 23.

In August, Buchanan placed an order for a new Nautel transmitter. It has been advised that the transmitter is nearly complete and is expected to ship around the end of November. Barring any unforeseen complications, the transmitter should be installed, tested and in operation next month. Accordingly, we respectfully submit that an extension of STA is appropriate, as the licensee has made substantial progress during the current STA period toward restoring licensed operations.

Submitted herewith is the licensee's Anti-Drug Abuse Act Certification, together with its check (#2417) in the amount of \$135 in payment of the Commission's application fee for STA for one commercial AM radio station (Fee Code MGR) and a Remittance Advice (FCC Form 159) reflecting this payment.
