Dear Mr. Kelly:

This is in reference to the request filed on November 15, 2013. BMH requests further extension of the STA granted on November 9, 2012, to operate Station KXET with reduced power.¹ In support of the request, BMH states that it remains in the process of determining how to resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


We noted that the request repeats earlier explanations, and did not provide any new information. Nevertheless, we will grant an extension of the STA for an additional six month period, however, unless licensed operations have been restored, any request for further extension of this STA must provide specific details of what steps the licensee has taken during the previous six months towards resumption of licensed operations.

¹ KXET is licensed for non-directional operation on 1150 kHz with 5 kW day and 0.01 kW night.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KXET may continue to operate during daytime hours with reduced power. It will be necessary to further reduce power or cease operation if complaints of interference are received. BMH must notify the Commission when licensed operation is restored.² BMH must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **May 13, 2014**.
