Dear Mr. Liberman:

This is in reference to the request filed on November 25, 2013. TMTL requests extension of the STA granted on December 4, 2012, to operate station KOSY with parameters at variance from licensed values and/or reduced power while maintaining monitor points within license limits.¹ In support of the request, TMTL states that STA operation is required to allow additional time to complete all repairs.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KOSY may operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or

cease operation if complaints of interference are received. TMTL must notify the Commission when licensed operation is restored.² TMTL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. It is anticipated that TMTL will restore licensed operations (and file an FCC Form 302 application if needed to update all operating parameters) before the expiration date shown below.

This authority expires on **June 20, 2014**.
