Dear Mr. Liberman:

This is in reference to the request filed on December 4, 2013, by Townsquare Media Momnouth-Ocean License, LLC (TMMO). TMMO requests an extension of the STA granted on June 12, 2013, to operate station WOBM(AM) with parameters at variance from licensed values and/or reduced power while maintaining monitor points within license limits.¹ In support of the request, TMMO stated that it will file an FCC Form 302 application with a partial proof within a few weeks to request new operating parameters.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for STA IS HEREBY GRANTED. Station WOBM(AM) may

continue to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. TMMO must notify the Commission when licensed operation is restored.² TMMO must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 27, 2014**.
