Please consider this letter an official request of North Alabama Public Service Broadcasters seeking the dismissal of the currently pending application for new construction permit (BPL-20130813AAV). An offer has now been made to North Alabama Public Service Broadcasters that was previously unavailable. This offer will allow the WQJJ-LP transmitter site to be permanently relocated to the studio site of WIXI(AM) and will more adequately serve in keeping the WQJJ-LP city-grade (60dbu f50,50) signal covering the city of license. We are prepared to submit a new application for construction permit for the location upon dismissal of BPL-20130813AAV.
