Dear Mr. Lipp:

This is in reference to the request filed on January 31, 2014. CBC requests a fifth extension of the STA granted on January 25, 2011, to operate with an emergency ND antenna and reduced power.<sup>1</sup> In support of the request, CBC states that the licensee has obtained quotes for all repairs (phasing equipment, ground system, array adjustments) so that an FCC Form 302-AM license application with a proof can be filed with the Commission in order to resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WKY may continue to operate with an emergency ND antenna using the 94.6° night tower #2(SW),



<sup>1</sup> WKY is licensed for operation on 930 kHz with a 5 kw ND antenna day and a 5 kW DA antenna at night.

and reduced power not to exceed 5 kW daytime and 1.25 kW nighttime, as necessary to facilitate all repairs. Operation also is authorized during nighttime hours with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. CBC must notify the Commission when licensed operation is restored.<sup>2</sup> CBC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **August 25, 2014**.
