Dear Mr. Kelly:

This is in reference to the request filed on March 7, 2014. DMC requests a second extension of the STA granted on March 12, 2013, to operate station WDMC(AM) with emergency antenna facilities pursuant to 73.1680 due to the need to change sites (existing site towers rusted and beyond service life).¹ In support of the request, DMC has filed an FCC Form 301 application to change site and construct a new three tower array in order to move forward towards resumption of licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:


- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

¹ WDMC(AM) is licensed for DA operation on 920 kHz with 5 kW day and 1 kW night.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WDMC(AM) may operate with an emergency ND antenna and reduced power not to exceed 1.25 kW day and 0.25 kW night. It will be necessary to further reduce power or cease operation if complaints of interference are received. DMC must notify the Commission when licensed operation is restored.² DMC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 1, 2014**.
