Dear Ms. Hunt:

This is in reference to the request filed March 31, 2014, on behalf of Kenai Educational Media, Inc. ("KEM"). KEM requests special temporary authority ("STA") for operation at 100 watts effective radiated power (0.100 kW) from a temporary transmitter site in the urbanized area of Seward. This is effectively a request for reinstatement of the April 25, 2013 STA grant.

The request to reinstate the STA IS HEREBY GRANTED. Station KIBH-FM may continue to operate with the following facilities:

¹ KIBH-FM's previous STA, BSTA-20130414AAG, was granted April 25, 2013 and expired by its own terms on October 22, 2013. Consequently, KIBH-FM operations between October 23, 2013 and April 2, 2014, have been unauthorized, and the grant of this STA today does not cover that period. We caution the licensee to pay closer attention th the STA expiration date, and file a request for extension before the STA expires.

We expect that KEM shall continue the temporary operation authorized herein, without interruption, through the term of this STA period or until the licensee implements the permanent installation authorized by construction permit BMPED-20130424AAG (or such other construction permit that the staff may approve). Extension requests for this STA may be granted by the staff if circumstances warrant.

KEM must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. Warning signs that describe the nature of the hazard shall be posted at all entrances to the roof, and on the roof itself at appropriate locations. See 47 CFR § 1.1310.

This authority expires on September 29, 2014.
