
Dear Applicant:

The staff has under consideration the above-captioned application for a new low power FM (LPFM) station.

According to the Commission's rules (the "Rules"), a LPFM station will only be licensed to a nonprofit educational organization upon showing that the station will be used for the advancement of an educational program. Section 73.853 of the Rules requires such a LPFM applicant to be a registered non-commercial educational organization or institution.<sup>1</sup> Applicants are required to submit complete copies of the documents establishing their nonprofit status, such as corporate charters or articles of incorporation.<sup>2</sup> You have failed to submit any such documentation. Therefore, the application will be dismissed.

Accordingly, application BNPL-20131114BSM is unacceptable for filing pursuant to 47 C.F.R. § 73.3566(a) and IS HEREBY DISMISSED.<sup>3</sup> This action is taken pursuant to 47 C.F.R. § 0.283
