## FURTHER SUPPLEMENT TO PETITION FOR RECONSIDERATION

Toccoa Falls College ("the College") licensee of WTXR(FM), Toccoa Falls, Georgia, by its counsel, respectfully files this Further Supplement to the College's Petition for Reconsideration filed August 27, 2012, directed to the Media Bureau's ("MB") *Forfeiture Order*, 27 FCC Rcd 8365 (2012) that imposed a \$10,000 forfeiture on the College for alleged violation of Section 73.3527 of the Rules by "failing to retain all required documentation in the WTXR(FM), public inspection file...." On November 1, 2012, the College filed a Supplement to its Petition for Reconsideration accompanied by a Petition for Leave to Accept Supplement to Petition for Reconsideration. The staff has requested additional information, which is provided herewith.

The Vice President for Business & Finance of the College has informed undersigned counsel, via electronic mail, copy attached, that the WTXR budget for 2010-11 was \$2,300 which included \$1,800 for student wages and \$500 for operating expenses. The actual incurred expenses for that year were \$2,304 of which \$1,586 was for student wages and \$718 for operating expenses.

In light of the foregoing additional information and the arguments set forth in the College's Petition for Reconsideration, and its Supplement to Petition for Reconsideration, the College respectfully requests the MB to vacate the *Forfeiture Order* and terminate this proceeding.
