SUBJECT: INFORMAL PUBLIC COMMENT OPINION REGARDING THE RELICENSURE OF KVLV TELEVISION – FARGO, NORTH DAKOTA. COMMENT PERIOD ENDING 3 MARCH 2014... COMMENTS EFFECTIVE UPON MAILING.

RECOMMEND: Divestiture of one of two network affiliations to an entity without current local ownerships presently to allow for a more open competitive presentation of local news – as one entity KVLV currently chooses all local news coverage for two network affiliates CBS/NBC - lessening the chances of nonpolitically influenced reporting and increasing the absolute mediocrity of broadcast personality promotion and razzle dazzle investigations of restaurant sanitation rather than reporting essential public interest reportage in depth and analysis of political corruption in law, politics and judicial affairs.

THE PUBLIC INTEREST IS NOT BEST SERVED BY THIS PRESENT SITUATION IN THE CHOOSING, PRODUCING AND DELIVERY OF THE NEWS LOCALLY

Dear Mr. Chairman, Commissioners and FCC Personnel,

I am a citizen of North Dakota and receive my television by broadcast transmission and not through cable or dish. KVLY is unfortunately, two of the local news channels broadcast – on both channel 4 where in Fargo, North Dakota they broadcast their news as the local CBS affiliate and on channel 11 where they broadcast the same local news as the NBC affiliate. Locally, their news competition is the ABC affiliate and Fox affiliate broadcast local news – channels 6 and 15 respectively.

It is my opinion that the news coverage in the area is determined by a considerable degree of political “do not report” bias weighing in against any determination to report on actual government corruption. WDAY is owned by the Forum Communications which owns the predominant newspaper – the Fargo Forum and a number of other newspapers and other media outlets.

The Fargo-Moorhead metro area has grown to a population of about 203,000 people – with the trade area being larger. KVLY is not alone in this perceived manufacturing and delivery of “news light”. The station was involved in an age discrimination lawsuit by a popular former female co-anchor who was replaced by a female co-anchor in her 20s and was viewed as being hired as eye candy for the demographic of men 18-45. The older woman was hired by the Forum and WDAY. On air personalities are not the major problem so much as the one entity picking the same stories and “investigations” for two different network affiliates – in a situation where “news lite” is good enough – journalists need not be aggressive in the gathering and reporting of the news.

KVLY is overstaffed in several areas to include meteorology , they advertise 4 meteorologists(point being is that 2 of them could work in each of two separate weather departments of separate CBS and

NBC local affiliates), the area needs responsible news coverage and not 10 on air meteorologists. When editorial and production and coverage decisions are made – they are made by the same individuals and for the detriment and edification of both NBC Nightly News with Brian Williams watchers and CBS Evening News with Scott Pelley viewers – by habit the viewer will usually simply just continue watching the local news before or after the national broadcasts.

KVLY should be made to divest one or the other network affiliation to allow more competition and more unbiased determination that likely would be made by having the NBC and CBS affiliates competing locally for viewers by trying to be the station with the better news program and hopefully a greater latitude in determining what shall be covered in regard political and public corruption.

KVLY has a whistleblower hotline where viewers are invited to call in and leave information regarding fraud and corruption – the toughest story was perhaps confronting the largest Real Estate Company in the area with complaints about insufficient heat in one apartment building and brides who had been left in the lurch when the brides dress company went out of business without sufficient cash safeguards.

News ideas can be developed, and are, (opinion) simply by reading the newspaper and doing a story, add a syndicated health feature about the latest mammography or prostrate “news”, add restaurant beat and do two stories from the paper the news show is pretty much done, rather than having 5 entities aggressively pursuing corruption of the public trust and finances ---- just read the court filings occasionally and ask doggedly some questions – and do not feel it necessary to be Facebook friends with individuals you have a responsibility to report on.

Largely to completely unreported, are bona fide and publicly known corruptions by members of state and local government at the highest levels. Matters that KVLY and other “news “ bureaus are aware of.

Sometimes these matters are pick-up and reported on line by bloggers in the state – Among them is Say Anything dot com. – that has reported about the failure of the Attorney General and County States Attorney in Fargo to either form Grand Juries or conduct comprehensive investigations and then prosecute – for instance North Dakota State University President Dean L. Bresciani – who despite being ineligible for applying for the position he was hired for due to his firing by Texas Governor Rick Perry at Texas A & M University was hired in Fargo and has since been implicated in over 45,000 counts of Class C Felonies of Destruction of Public Documents by a Public Official – coverage of matters like this or the sending of the campus police off campus to intimidate disabled veterans into revealing the identity of their friends who the police falsely insinuated that the veterans friend had broken the law – by that time in the evening the President (Bresciani) had already e-mailed to the Chancellor of State Higher Education and the President of the Board that the Veteran had broken NO laws . Irrespective a No Trespass Warning was then served upon the second veteran’s residence– illegally, as a Federal Judge had already ruled such conduct was an illegal prior restraint on speech.

Creepily the Police labeled the report “in-house” and have refused to – against the law – refused to release a copy of their report and other documents arising out of their criminal activities.

Such matters are of the order of Do not inquire – do not report – on the part of local media.

The ND Attorney General Wayne Stenehjem responsible for ruling whether a record must be released under the law, has recently – again - followed the pattern of the North Dakota court system – and that is to refuse to maintain a records of malfeasance of state office holders - and therefore as the matter does not exist – he will take no further action on a matter (having taken none in the first place). An example of this practice is enclosed as a transmittal of an entire investigation to ND Risk Management – the court system having conducted the investigation – maintained no documentation – with the hope it will not be found out(State Court Administrator Sally Holewa to Risk Management {an 84 page investigation} dated March 14, 1012)

Most troubling perhaps is the complete failure of law enforcement, prosecutors, the State AG, and the ND United States Attorney and all media outlets , to include KLVY twice – for both affiliates....To report the use of the state’s courts as a place and methodology of money laundering to defeat federal taxes, conspiracy to evade taxes, the actual evasion of tax and what must be viewed as the knowing complicit subornation of perjury by the seated Judge John C. Irby.

The Court stated that the tax forms were properly prepared – utterly ignoring the facts that the financial figures on which such calculation were made were fraudulent- five promissory notes and a statement of Congressman Berg’s real estate partner’s attorney recounting the partner’s testimony on the witness chair before the court of another loan of \$600,000.00.

Enclosed are copies (from the Cass County ND court file Craig v. Craig) of the false promissory notes (5) purported to be genuine documents and the statement of plaintiff’s attorney reiterating the statement of the congressman’s real estate partner that Berg (the sitting congressman at time of the attorney’s statement to the court) and 20 year veteran of the legislature at the time of the creation of false documents for the court.

In addition to ordering of the divestiture of one element network affiliation of KVLV and independent investigation of the commission and it’s Office of Inspector General – would be the Persons and the Offices of the Chairman and Commissioners to forward to the Honorable Eric Holder and the Justice Department of the United States information regarding the breaking of federal laws by the powerful in North Dakota.

Only one independent news print outlet had the courage and fortitude to even print one letter to editor regarding the Felonies of Congressman Richard Alan “Rick” Berg and the Judge for the subornation of perjury and the creation of a monumental false fraud upon the courts and the Peace and Dignity of the State of North Dakota, by the real estate partner of Congressman Berg. The allegation made in the letter and in one small election print advertisement was not denied by the Berg for Senate campaign. First Class Mailings were sent to all Valley media television broadcast outlets – including KVLV and state newspapers and the AP, with the apparent determination being not to report.

The Senate campaign of Berg failed – as it appears that they were very confident that Citizens United’s determination would prevail over all facts and ethics – the allegations are to the best of our knowledge – factual and demands a special prosecutor and/or Federal Grand Jury – as the new current U.S. Attorney for North Dakota spends most of his time participating in local prostitution stings – rather than pursue the corrupt personal political friends of the last US Attorney Mr. Drew Wrigley– now the LT Governor – originally appointed , the personal friend of the now Governor and also political ally and co/strategist of the sitting Governor Jack Dalrymple

. The same handful of individuals appear over and over in the machinations of rewards to – for instance – the Governor – who has received over 4.7 million dollars in wheat subsidies in the last 14 years and his personal Congressman Kevin Kramer while exclaiming the farm program is required for persons like Dalrymple (from Judge Irby’s small, small hometown) but the food SNAP program recipients should not eat as they do not work – quoting some Bible verses. Thanks for your service.

Should any member of Federal Investigatory authority or local, regional or national media like to have more information shared with them regarding where absolute - i.e. Very likely to have a Jury find as beyond a reasonable doubt standard evidence is – and who it implicates etc. etc.. simply contact me, for instance. No such records are likely to be found at businesses operating allegedly in the public interest – like KVLV – in my opinion does not operate in the public interest and should be compelled to divest – to a current non regional player in media – if not having its license fully denied – upon independent investigation into reporting practices by licensed media in this region.

Enclosed is the Howela letter – part of the 84 page Sexual Harassment investigation report – being purged by the conductor of the investigation – the North Dakota Court System – that shows just one tactic in the pattern of hiding evidence of public evil doing by law enforcement and others – perhaps most media for instance – who have other motives – such as personal aggrandizement and speaking fees, over that of developing any basic journalistic source development, and skills in research -- and determination to report essential facts to the taxpayer – those that are harmed by the unequal administration of laws and the prior restraint of speech by the often same group of evil doers – Malefactor is one term used to describe President Dean L. Bresciani (– fired according to Texas Monthly under the personal orders of Texas Governor Rick Perry), by one North Dakota State Republican

Further under this individuals administration over 90% of all voter fraud in the entire United States was committed by members of the NDSU football team – these individuals described by the Judge as being too intellectually deficient to understand the criminality of their actions – which includes forging Hillary Clinton’s name on one line of 15,000 plus forgeries on voter initiative petitions – and then declaring the truthfulness of said signatures on sworn affidavits - they were not subject however to even a one game suspension for thousands of felonies – conveniently packaged as one count of a pleaded down misdemeanor. Please note that one assertive blogger in a micropolitan community 300 miles distant from KVLV’s main coverage area (Minot, ND) has more comprehensive news regarding corruption in government than does for example – newspaper pursuing KVLV.

I would be happy to show such actually interested regional/national reporters and Federal Agents investigating Federal officials evidences that they may feel they cannot find or develop or report on without a member of the public leading them to it -- I will do so if asked by a person reasonably seeking the truth in matters of public corruption – to include the North Dakota Attorney General office declaration, to the effect, that they will not maintain a record implicating Mr. Berg (close associate of State AG) or Judge Irby.

Please see the Howela example of not maintaining records (it is a popular method of keeping the public and media in the dark –) and her only person to report to is the Chief Justice of the State Supreme Court – and can we wonder (!) why there is no investigation of Judge Irby – when records can just be – not maintained – proof not preserved, and the Judicial ethics board – having not much to do – having nothing to look at – well maybe not really – like many things in reportage in North Dakota – maybe not

really..... The divorce action in which the money laundering appears to have occurred is Craig v. Craig a reopening (Cass County – Fargo ND) for the unconscionable nature of the agreement in the matter (the venue was also knowingly misrepresented – as they – the Craigs never lived in the North Dakota rental property owned – never lived in by the Minnesota domiciled couple – the matter had to be HAD TO BE gotten in front of Judge Irby (the political appointee there for a purpose!) . Expert opinion documents do not mention the 1.4 million in funding from Berg to Craig --- because such events – never occurred --- they lack collateral, they lack witnesses, they lack appearance before a notary in a business of Mr. Berg's that must have a number – let alone the banks that would have cut the funds to Mr. Craig – had that actually occurred – but what occurred actually was a series of Federal Crimes. Such funding do not even anywhere allege to be for real estate equity buy-ins, but instead in numerous places in the file maintain that the funds were for wild recreational spending – such funds came only from distributions through the business interests. KVLV reporters that now charge \$12,000.00 for personal appearances prior to switching from a Friend set-up to a Follower set-up on Facebook maintained the Congressman (ex) as a "Friend".

Also Commissioner's and Chiefs of Staff of each Commissioner. – Please see that a copy of your mailing here gets to the KVLV relicensing evaluation team at FCC – where it is being sent as well independently – but as we know – things get misplaced, lost, unaccounted for – at times – as best as I can figure out where to send it in the FCC and mailed on March 3, 2014 – this date included in the public comment period and this mailing to the Chairman, Commissioners and the KVLV responsible parties at FCC being effective according to law – when mailed.

So please – ALL please refer this to the attention of the Honorable Eric Holder – the Attorney General of the United States for my here suggested appointment of Special Prosecutor – formation of Federal Grand Jury – even the close supervision of the United States Attorney's Office if ordered to pursue the matter would not likely engender any "Will do" Sir – by a North Dakota office where everyone knows everybody and the only really priority if the carrying out of the death penalty on Alfonso Rodriguez for the Federal Capital Murder of Dru Sjodin .
