RESPONSE TO INFORMAL OBJECTION

Alaska Educational Radio System, Inc. ("AERS"), by its attorney, hereby responds to the "Informal Objection" to its abovereferenced application for consent to assign the license for Station KABN-FM, Soldotna, Alaska to Kenai Cares, Inc. ("KCI") that Turqouise [sic] Broadcasting Company, Inc. ("TBC") filed on April 16, 2014. As neither AERS nor KCI were served with a copy of the Informal Objection and its existence was only discovered fortuitously on April 23, 2014, when the President of KCI checked the status of the application in CDBS, this Response is timely.

Since the Informal Objection was not served upon either AERS or KCI, it is a prohibited *ex parte* presentation and should be treated as such in accordance with Section 1.1212 of the Commission's Rules which prohibits such presentations from being considered in determining the merits of this proceeding unless and until the Commission decides that the presentation should be "made part of the record and the parties are so informed."

If notwithstanding the *ex parte* nature of the Informal Objection it is considered by the Commission in determining whether to grant the subject assignment application, Assignor and Assignee make the following responses to the substantive allegations made by TBC to the extent that they can be discerned.

1. There was nothing improper in Mr. Dunham taking steps to place Station KABN back on the air as he did so as an engineer under the direction of the President of the licensee, Mr. Kurtz.

2. There is no merit to TCB's claim that Mr. Kurtz is a party to a proceeding which left a character issue against him unresolved. The "proceeding" cited by TCB to support this claim, NAL DA 09-2627, pertains to a Notice of Apparent Liability issued in a rule violation proceeding which did not involve any "character issues" within the meaning of that term as used by the Commission in assessing the qualifications of parties to be licensees. Similarly, while TCB has made extensive allegations in petitions to deny applications of AERS and of another entity controlled by Wolfgang Kurtz, Seward Media Partners, those allegations concerned the operations of stations by those entities, the financial qualifications of the entities, the status of the Alaska business license of one of those entities, as well as other matters, none of which matters involve "character issues" within the meaning of that term as used in Question 5 under Section II of FCC Form 314.

Wherefore, for the foregoing reasons, it is submitted that TCB's Informal Objection does not raise any issue relating to the qualifications of AERS to assign the license for KABN-FM or of KCI to become the licensee of that station, and, accordingly the Objection should be summarily dismissed.
