Dear Counsel:

This is in reference to the request filed April 25, 2014, on behalf of Amarillo Junior College District ("AJCD"). AJCD requests special temporary authority ("STA") to continue operating station KACV-FM with temporary facilities, erected after the April 19 failure of the station's transmission line. The temporary facility's coverage is said to cover KACV-FM's community of license.

Section 73.1680 of the Commission's rules provides for operation with emergency antenna facilities following damage to authorized antenna systems, provided that an informal request for continued use of an emergency antenna is filed with the Commission within 24 hours. In particular, Section 73.1680(b)(2) provides that FM and TV stations may erect any suitable radiator, or use operable sections of the authorized antenna(s) as an emergency antenna.

Accordingly, the request for STA IS HEREBY GRANTED. Station KACV-FM may operate with the following temporary facilities:

Coordinates:	35° 11' 14" N , 101° 50' 46" W.
Channel:	210 (89.9 MHz)
Effective radiated power:	0.02 kilowatts (H)
Antenna height:	
above ground:	21.3 meters
above mean sea level:	1143 meters
Above average terrain:	46 meters

AJCD must notify the Commission when licensed operation is restored. AJCD must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **November 3, 2014**.
