


Statement of Tammy M. Celenza

I, Tammy M. Celenza, am the Licensee of FM Translator W227CL, Coram, New York (Fac. ID 142505)(the "Station"). An issue has arisen with respect to my current rebroadcast of Radio Station WLIX and M. Celenza Communications, Inc., Licensee of W245BA, Manorville, New York (Fac. ID 139341) (owned by my husband Michael Celenza) proposed rebroadcast of the same station. The Audio Division Staff indicated because we are not allowed to rebroadcast the same station as our signals overlap more than 50% with each other *and* because we are related, thus assuming we were the same. This is not the case. My husband and I keep our interests separate.

I own my translator individually. I have my own separate bank account for the Station. I pay all regulatory fees, filing fees and taxes due for the Station. I pay my own legal fees. I have my own Lease Agreement (page one of my Lease Agreement is attached) and pay my own rent on the transmitter site (copy of check attached). I also have my own insurance on my station (see certificate of insurance attached). At this time, I am also assigning my station license from myself as an individual to my corporation, of which I am sole officer director and shareholder, TMC Broadcasting, Inc. (see BALFT-20140430AAS) and expect to consummate that transaction upon staff approval. This assignment will provide additional separation between my interests and those of my husband.

While it is true that my husband did assist with the engineering and certain application processes, when I applied for the Station; I have always remained in control. I believe this information is sufficient to show that I am separate from my husband's corporation and comply with the Commission spousal cross ownership policy.
