Dear Mr. Kelly:

This is in reference to the request filed on May 12, 2014. BMH requests a fourth extension of the STA originally granted on June 8, 2012, and modified on November 9, 2012, to operate Station KXET with reduced power due to transmitter equipment vandalization. In support of the request, BMH requests further extension to develop a plan to resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We noted that the request did not submit any new information from the past six months to verify that substantial progress had been made toward resumption of licensed operations, or provide a list of what other repairs/steps have been completed (and those that remain). As a result, we will grant an extension of the STA for a three month period to allow BMH

additional time to complete all repairs and install a new 5 kW transmitter (if needed) in order to resume licensed daytime 5 kW operations.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KXET may continue to operate during daytime hours with reduced power. It will be necessary to further reduce power or cease operation if complaints of interference are received. BMH must notify the Commission when licensed operation is restored.² BMH must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. Failure to resume licensed operations before the expiration date shown below may lead to a cancellation of this STA.

This authority expires on September 5, 2014.
