

Dear Ms. Dortch:

Radio License Holding CBC, LLC ("RLH"), by its counsel, respectfully requests a two week extension of time to respond to the Audio Division, Media Bureau's letter of April 4, 2014 requesting additional information concerning the above referenced license application. The letter cited certain deficiencies and requested an amendment with reference to the following matters—

- 1) *"Applicant did not include the actual measurements to establish that sampling devices agree within the manufacturer's rated accuracy in accordance with Section 73.151 (2)(i)."*
- 2) *"Paragraph 3 of Exhibit #1 states that the modeled and measured base impedances at the ATU output jacks, with the other towers short circuited at their ATU output jacks agree within +/- 2 ohms and +/- 4 percent for resistance. However, it appears that the modeled and measured base impedances that are compared in Exhibit #1A are for open circuit conditions. Licensee will need to clarify Exhibits 1 and 1A."*

With regard to Item #2 above, RLH is prepared to amend the license application to specify that the other towers are open circuited instead of short circuited. This was a typographical error. However with regard to #1, additional time is needed to submit the amendment. There was a delay in taking the additional measurements

that were needed to establish the accuracy of the sampling devices. Just last week, RLH's consulting engineer was hospitalized for surgery and has not been available to complete his evaluation of the measurements and prepare the amendment.

Accordingly an additional two week period, until **June 17, 2014**, is respectfully requested to submit the amendment. Please contact undersigned counsel to Radio License Holding CBC, LLC if there are any questions.
