Dear Ron and Hossein:

There appears to be some kind of glitch in CDBS as the antenna data for BPTTA-20140609ACB (Section 10) in CDBS Application Search Result does not match with the antenna data specified in the application as-filed in our CDBS account 937788. I took screenshots of the antenna data, see attached CDBS glitch (20140609ACB).pdf.

As you can see, the antenna specified in the as-filed application is a Directional Composite SCA CL-1469 oriented at 162 degrees and the Directional Antenna Relative Field Values are specified. Also attached is a PDF copy of the as-filed BPTTA-20140609ACB pulled directly from the licensee's CDBS account 937788 in case you need it.

In regards to the two issues in your email below, we will coordinate with the NRQZ, and we believe with the correct antenna data, you will find the proposed facility is shrinking coverage in all directions from the authorized site and therefore the proposed analog contour does not extend beyond the existing analog license contour.

Ms. Stewart, I am writing to advise you of the status of the analog minor change proposal BPTTA-20140609ACB:

Our engineering analysis reveals the following issues:

1. FCC monitoring station(s), Table Mountain and Quiet zone study. The proposed antenna site is located in the West Virginia quiet zone.
Coordination is required.
2. Attached please find for your reference and review our contour study of which the existing analog license contour is indicated in yellow and the proposed analog contour is indicated in red. As you can see the proposed analog contour does extend beyond the existing analog license contour which is in violation of Public Notice DA 13-618 – Released April 5, 2013 – Titled: Media Bureau Announces Limitations on the Filing and Processing of Full Power and Class A Television Station Modification Applications, Effective Immediately, and Reminds Stations of Spectrum Act Preservation Mandate.
