Dear Mr. Friedman:

This is in reference to the request filed on June 17, 2014. SBC requests an extension of the STA granted on December 20, 2013, to operate station WRRZ(AM) with emergency antenna facilities pursuant to Section 73.1680 due to the collapse of the station's tower.¹ In support of the request, SBC states that it has commenced the process of replacing the tower due to receipt of the related insurance settlement.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for STA IS HEREBY GRANTED. Station WRRZ(AM) may continue to operate with the following facilities:


¹ WRRZ(AM) is licensed for daytime only ND operation on 880 kHz with a power of 1 kW.

Coordinates: 34° 58' 40" NL, 78° 18' 15" WL (NAD 1927)
Frequency: 880 kHz
Operating hours: Daytime only
Operating power: Not to exceed 1 kW
Antenna: Horizontal wire
Antenna efficiency: Unknown
Overall height 15.2 meters (50')

It will be necessary to further reduce power or cease operation if complaints of interference are received. SBC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. We anticipate that SBC will complete all work and file an FCC Form 302 application before the expiration date shown below in order to verify the return to licensed operations.

This authority expires on **November 11, 2014**.
