Dear Mr. Jazzo:

This is in reference to the request filed on June 18, 2014. ZRI requests a third extension of the STA granted on November 13, 2012, to operate Station KZYM with emergency antenna facilities pursuant to Section 73.1680 due to collapse of the tower. In support of the request, ZRI stated that additional time will be needed to file a license application to cover the permit (BP-20131029ADR).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for STA IS HEREBY GRANTED. Station KZYM may continue to operate with the following facilities:

¹ KZYM is licensed for non-directional operation on 1230 kHz with 1 kW(day and night).

It will be necessary to further reduce power or cease operation if complaints of interference are received. ZRI must notify the Commission when licensed operation is restored.² ZRI must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. We anticipate that ZRI will file an FCC Form 302 application to cover the permit before the expiration date shown below since using the existing tower noted above.

This authority expires on October 15, 2015.
