Ms. Corbin, We are attempting to rush process the digital minor modification as requested. However, The digital minor modification BMPDTL-20140825ABQ for station K29GL has two deficiencies that will require an amendment to correct.

The two deficiencies are as follows:

1. The rcamsl seems incorrect; please check. rcamsl = 323.0 gamsl = 370.0
Warning *** The antenna for BMPDTL-20140825ABQ seems to be underground!! ***
The Radiation Center Above Mean Sea Level is 323.0 meters, but the Ground Level Above Mean Sea Level is 370.0 meters.
The proposal shows 323.0 m is the value used for Radiation Center Above Mean Sea Level
2. The protected contour of the proposed digital facility BMPDTL-20140825ABQ do not overlap with the protected contour of the existing analog license facility BLTT-20060106ADI.
