Dear Applicant:

This letter refers to: (1) the above-captioned minor change application filed by Klamath Falls SDA Church ("Klamath Falls") for a new station in Klamath Falls, OR; and (2) the above-captioned contingent minor change application filed by Educational Media Foundation for KLKF. For the reasons set forth below, we dismiss both applications.

Section 73.7002(c) of the Commission's Rules provides that for a period of four years of on-air operations, an applicant receiving a decisive 307(b) preference must "construct and operate technical facilities substantially as proposed and shall not downgrade service to the area on which the preference was based." Klamath Falls has neither constructed nor operated, for any period, the authorized facilities for which it received a decisive 307(b) preference. In addition, the facilities specified in the application result in the removal of service to part of the area on which Klamath Falls' decisive 307(b) preference was based. This was not acknowledged in the application.

In light of the above, Application BMPED-20140806AEU is unacceptable for filing pursuant to 47 C.F.R. § 73.3566(a) and is HEREBY DISMISSED. We note that this application was filed as part of a contingent application group with BPED-20140806AEY. Pursuant to 47 C.F.R. Section 73.3517(e), dismissal of any one of the related applications as unacceptable will result in the dismissal of all the related applications. Therefore, Application BPED-20140806AEY IS HEREBY DISMISSED. These actions are taken pursuant to 47 C.F.R. Section 0.283.
