Dear Mr. Lipp:

This is in reference to the request filed on February 18, 2014. RLHC requests an extension of the STA granted on August 22, 2013, to operate station KKAT(AM) with reduced power using the nighttime transmitter during daytime hours due to severe damage to the station's daytime transmitter.¹ In support of the request, RLHC states that they continue to search for obsolete components to repair the transmitter, but have decided it would be beneficial to wait for final action on MB Docket 13-249 before determining the best course of action to restore licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:


- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

¹ KKAT(AM) is licensed for ND operation on 860 kHz with 10 kW (D), 3 kW (CH), and 0.196 kW(N).

Accordingly, the request for STA IS HEREBY GRANTED. Station KKAT(AM) may continue to operate with reduced power. RLHC must file an acceptable FCC Form 301 application to modify the facility when the MB Docket 13-249 has been adopted (or replace the transmitter if unable to repair by that date), and then notify the Commission when licensed operation is restored.² RLHC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 18, 2015**.
