DECLARATION OF DAVID J. WILHELM

- I, David J. Wilhelm, declare under penalty of perjury that the following statement is true and correct.
 - 1. I am the CEO and Treasurer of MMM License LLC ("MMM").
- 2. On or about February 5, 2004, MMM filed a document with the Federal Communications Commission titled "Petition to Revoke and Deny the Licenses, Authorizations and Applications of Rocky Mountain Broadcasting Company and Beartooth Communications Company" (the "Petition").
- 3. I am aware that to date there has been no resolution of the matters raised in the Petition nor has action been taken on the applications of Beartooth and Rocky Mountain.
- 4. At the time of filing, MMM was the licensee of the following stations: KTGF-TV, Great Falls, MT; KWTB-TV, Butte, MT; KTMG-TV, Missoula, MT: KWYB-LP, Bozeman, MT, KTMF-LP, Kalispel, MT, and K47DD, Learston, MT, MMM also had pending at the time applications to acquire stations KFBB-TV, Great Falls, MT, and KHBB-LP, Helena, MT.
- 5. At the current time, MMM is not the licensee or permittee of any broadcast stations in Montana and accordingly, no longer has an interest in prosecuting the Petition. MMM respectfully requests that the Petition be withdrawn.
- 6. Neither MMM nor any of its officers, managers or principals have received or been promised any consideration for its decision to withdraw the Petition.
