Dear Sirs and Madam,

In response to your correspondence dated September 10, 2014, we respectfully request cancellation of forfeiture for not filing electronically Quarterly Children's Reports and our TV issues/programs list for the following reasons discussed below.

When we went from Channel 49 to 26 and our facility number went from 35255 to 190120, our Quarterly Children's Reports, issues/program lists and all other electronically filed material on our FCC site disappeared. After contacting Hossein Hashemzadeh, he was able to find it and return it to our new facility number. We were unaware that it had disappeared again until we received your letter. At that time we again contacted Mr. Hashemzadeh and the Children's Reports have returned but not anything else as of this date. I do have the information and can upload it again if that is what needs to be done. I also have the Submission Confirmations of all the Quarterly Children's Reports that I can send to assist in verifying the date of the Children's Reports you did find on our site at the time of your letter to show they were filed on time.

I fully understand the importance of the information to the viewing public and will do all I can to make sure it is on our FCC site again and will monitor it weekly to see that it remains there.

In reference to the late filing of our license renewal application, we had been assured repeatedly by our consultant that it would be done in a timely matter. That is our fault for not monitoring it right up to the deadline for filing. When we started wondering why we hadn't heard or received something about it
