Dear Applicant:

This is in reference to: (1) the above-captioned application dismissed by letter on May 30, 2014; (2) the amendment and Petition for Reconsideration filed on July 7, 2014; and (3) the July 14, 2014 Informal Objection filed by Donald Hullinger. The applicant requests reconsideration of the staff's May 30, 2014 dismissal of the above-captioned application.

By letter dated May 30, 2014, the staff informed WSU that the application was in violation of 47 C.F.R. § 73.509. Specifically, the proposed interfering contour (54 dBu) would cause prohibited overlap to the protected contour (60 dBu) of KCPW's license by as much as 2 kilometers between the azimuths from 181°T to 197°T. Consequently, the application was returned pursuant to 47 C.F.R. § 73.3566.

On July 7, 2014, WSU submitted a petition for reconsideration requesting reinstatement nunc pro tunc and a minor amendment. The amendment modified the site coordinates and antenna height. However, the application is still in violation of 47 C.F.R. § 73.509. Specifically, the proposed interfering contour (54 dBu) would still cause prohibited overlap to the protected contour (60 dBu) of KCPW's license. The applicant claims that this overlap is entirely over water. However, our plot shows overlap on land area with roads. The amendment, therefore, fails to eliminate the problem which resulted in the dismissal of the original application. Accordingly, WSU's petition for reconsideration will be denied.

In light of the above, WSU's July 7, 2014 Petition for Reconsideration IS HEREBY DENIED. Furthermore, the July 14, 2014 Informal Objection filed by Donald Hullinger IS HEREBY DISMISSED AS MOOT. These actions are taken pursuant to 47 C.F.R. § 0.283.
