Dear Counsel:

This is in reference to the requests filed November 17, 2014, for Cochise Broadcasting, LLC and Cochise Media Partners, LLC (“collectively Cochise”). Cochise requests a second extension of the November 13, 2013 special temporary authority (“STA”) to continue operating operate these three colocated facilities at reduced power. Previously, Cochise had indicated that building overheating problems occurred when all three stations are operated (presumably at full power). An STA extension is requested to allow continued reduced power operation by all three of these stations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Cochise's current extension request does not describe any actions taken by the licensee over the summer months (when access to the site was feasible) . Early winter weather now probably prevents resolution until the spring. We will grant a further extension so that these stations can maintain operation over the winter months.

Cochise must notify the Commission when licensed operation for each of these stations is restored. Cochise must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. We expect that Cochise shall maintain these STA operations for KWYX, KCYA, and KGRK throughout the term of this STA, until licensed operation recommences.

This authority expires **May 20, 2015**. **Any further requests for extension of this STA must include a description of all efforts made by the licensee to restore full power, licensed operation.**
