Dear Mr. Frandsen:

This is in reference to the request filed November 25, 2015, on behalf of M. Kent Frandsen ("MKF"). MKF requests an extension of the STA granted on June 3, 2014 (BSTA-20131216DSP), that modified the STA granted on December 7, 2005 and its several extensions.

Summarizing briefly from the June 3, 2014 staff letter, MKF has not implemented KNYN's required channel change to Channel 280C1, and station KUDE, Nephi, UT has not changed its channel to 256C. Frandsen has no operational licensed facility to protect and has operated solely on STA for nine years. The June 3, 2014 letter stated that KNYN's STA would not preclude KUDE from implementing its required channel change. MKH was served notice that the June 3, 2014 STA grant, and all extensions of it (including the present request), are subject to the condition that the KNYN STA operation must accept any and all interference from KUDE commencing operation on Channel 256C. MKF was advised that it must document its progress in implementing KNYN's tolled construction permit BPH-200071119AEV, and that failure to provide that information, or incomplete information, might result in modification of future STA terms, or cancellation of KNYN's STA authority on Channel 256.

MKF's current STA request indicates that MKF has been in discussion with the trustee of KUDE regarding alternatives, which may include undoing the mutual channel changes for KUDE and KNYN. MKF hopes to file a construction permit application for such changes in a couple of months.

Based on these statements, the request for STA extension IS HEREBY GRANTED subject to the condition that this STA will not preclude KUDE from commencing authorized operations on Channel 256, even if interference should be caused to this STA operation. Station KNYN may continue to operate with the following facilities:

Geographic coordinates: 41° 21′ 10″N, 110° 54′ 26″ W (NAD 1927)

Channel 256 (99.1 MHz)

Effective radiated power: 0.625 kilowatt (H&V)

Antenna height:

above ground: 5 meters above mean sea level: 2629 meters above average terrain: 456 meters

MKF must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on June 1, 2015.

Any future request for extension of this authority must include an attachment documenting MKF's progress in implementing the channel change to Channel 280C1 required by KNYN's construction permit BPH-200071119AEV. Failure to provide this information, or providing incomplete information, may result in modification of future STA terms, or cancellation of KNYN's STA authority on Channel 256.
