UNIVERSAL SETTLEMENT AGREEMENT

Applicants agree that this schedule may be changed upon a subsequent mutual agreement between all of the parties and submitted to the Commission per §73.870(a)(2) of the Commission's Rules.

No time share proponent is proposing simultaneous operation and none are proposing to operate with less than 10 hours per week in accordance with §73.872(c)(1) of the Commission's Rules.

FINDINGS

- 1. A settlement agreement has been reached between all of the parties in the above captioned proceedings.
- 2. Under the terms of the agreement, there were no payments or other consideration between the eight organizations.
- 3. The parties have determined it would be in the public interest to enter into this universal settlement agreement in accordance with §73.872(c) of the Commission's Rules. This settlement represents all three applicants that agree that acceptance of this universal settlement would serve the objectives of the Communications Act of 1934, as amended as well

as the rules and policies of the Commission. In addition, the settlement will conserve Commission resources, promote spectrum efficiency, promote localism and will result the expedited implementation of the proposed LPFM stations.

- 4. None of the parties filed their applications for the purpose of reaching or carrying out such an agreement.
- 5. The settlement agreements agreed into by the parties contain the entire understandings and undertakings between the parties pertaining to these matters.

CONCLUSION

Through the cooperative efforts of all three remaining applicants in MX Group # 402, we have reached this Universal Settlement Agreement to advance spectrum efficiency and cooperation between the applicants. This agreement will introduce new LPFM services to Milwaukee and the surrounding areas. We feel that this agreement meets the public interest, need and convenience.
