Dear Applicant:

This is in reference to the above-captioned application ("Iglesia Application") for a new Low Power FM ("LPFM") station.

By letter dated December 5, 2013, the staff dismissed the Iglesia Application for violating the minimum spacing requirements of 47 C.F.R. Section 73.807. On December 6, 2013, Iglesia filed a petition for reconsideration explaining that the applicant had specified registered tower #1062892 in its application and had simply mistyped the coordinates in the application, typing 95 degrees West longitude instead of 85 degrees West longitude. On December 22, 2014, the staff granted the petition for reconsideration and reinstated the corrected Iglesia Application.

By Public Notice ("PN") dated September 5, 2014, the Commission announced the mutual exclusivity of most pending LPFM applications filed to serve communities in Tennessee.¹ The PN provided a 90-day period for the filing of settlement agreements and/or major change amendments for all listed applications. In addition, the PN used a point system to tentatively select applications for grant, and initiated a 30-day period for filing petitions to deny against those applications tentatively selected.

However, the Iglesia Application was not included in the PN, because, at the time, the coordinates in the Iglesia Application remained at the originally specified location, outside the Chattanooga area. Therefore, the application did not appear to be mutually exclusive at the time Commission released the PN.

By this letter, we announce that the Iglesia Application should have been included in the PN in Group 328, along with Applications BNPL-20131114BCM and BNPL-20131113AAW, both proposing to serve Chattanooga, TN. Furthermore, we hereby announce the acceptance for filing of the Iglesia application and provide Iglesia with its 90-day period for the filing of a settlement agreement and/or a major amendment. Please refer to the PN for details regarding the requirements for the submission of either of these filings. Any such agreement or amendment must be on file no later than 6:00 pm May 4, 2015. Further action on the application will be withheld for 90 days.
