Dear Alpha Media Licensee:

This is in reference to the request filed January 9, 2014, on behalf of Alpha Media Licensee, LLC ("AML"). AML requests extension of the Special Temporary Authority that was previously granted July 22, 2013 to the former licensee of WJNT (AM), YMF Media Mississippi Media Licensee, LLC.¹ This STA was originally granted on December 20, 1999, and modified on February 19, 2004, to allow duplication of the programming of Station WJNT (AM) at night on FM "booster" WJNT-FM1 to overcome nighttime Cuban interference.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WJNT-FM1 may continue to operate, nighttime hours only,¹ with the following facilities:

AMF characterizes itself the "licensee" of WJNT-FM. That is incorrect. Inasmuch as this facility has only ever been authorized via Special Temporary Authority, continued operation of WJNT-FM is authorized provided that it continues to protect construction permits and licenses of other facilities, including authorized translators and boosters. Like its predecessors, no protection is afforded by this STA (or extensions thereof) against proposals that might conflict with this STA operation.

AML must take whatever steps are necessary to prevent exposure of workers and/or the public to radiofrequency fields in excess of the Commission's exposure limits. *See* 47 CFR Sections 1.1307(b) and 1.1310. This authority will terminate upon discontinuation of excessive power operation by Cuban Station CMGL. This authority is subject to modification or cancellation by the FCC without prior notice or right to hearing. *See* 47 CFR Section 73.1635(b).

This authority expires on **September 5, 2015**. AML is reminded that, pursuant to Section 73.1635(a)(4) of the Commission's rules, as well as Section 309(f) of the Communications Act, that the Commission may not grant an STA for a period longer than 180 days. Extensions of this operating authority may be granted upon request, provided that circumstances warrant.
