Dear Mr. Marek:

This is in reference to your request filed March 5, 2015, on behalf of KWSC-FM, licensee of KWSC, Wayne, NE.<sup>1</sup> KWSC-FM's explanation shows that it is continuing to make progress toward completing KWSC-FM's construction permit modification application, but needs a little more time to complete the work.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway; or
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

The licensee's statements satisfy these criteria. Accordingly, the request for STA extension IS **HEREBY GRANTED**. Station KWSC may continue to operate with reduced power using the single antenna bay. KWSC-FM must notify the Commission when licensed operation is restored. KWSC-FM must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.
