Dear Ms. Dortch:


In compliance with the Video Division's Letter order of November 7, 2014, PMCM TV, LLC hereby notifies the Commission that it will commence operations on virtual Channel 33.1 on or before 12 noon on March 16, 2015. We emphasize that this change in virtual channel creates considerable hardship for station WJLP and the action is taken on an interim basis only until the station is permitted to be identified by its over the air channel, Channel 3.

A supporting Declaration under penalty of perjury confirming PMCM's intended interim operation on virtual Channel 33.1 by the General Manager of Station Operations is attached.


