To Whom It May Concern,

I am writing to request an STA for WEGP - 1390 AM in Presque Isle, Maine silent. The station went silent today, on Monday, March 2<sup>nd</sup>. My request is to remain silent beyond the ten days when notice is not required --March 12<sup>th</sup>, 2015 – until March 31<sup>st</sup>, 2015.

I am the president of an S-Corporation (Decelles-Smith Media, Inc.) that owns WEGP. I live in Vermont, about 450 miles from Presque Isle, the market in which the station operates.

WEGP has had successive years of operating losses. In late 2014, my advertising representative resigned her position. Given the significant distance between my home and Presque Isle, Maine, I have been unable to travel to Maine to hire a replacement. WEGP has had limited sales and declining operating revenue in the intervening time.

On February 23<sup>rd</sup>, I accepted an Asset Purchase Agreement from The Presence Radio Network of Portland, Maine. Presence requested that I continue to transmit until the end of the broadcast day on Sunday, March 1<sup>st</sup> so they could continue to evaluate the radio equipment and transmission facility.

On March 2<sup>nd</sup>, given the financial difficulties and continued operating losses, I decided to cease radio transmission until Presence completes the transfer of the operating license. Assuming that WEGP is granted the initial 30 day STA, I intend to request an STA to *remain* silent, if the transfer of the operating license is not completed by March 31<sup>st</sup>.




