Dear Mr. Jacobs:

This is in reference to the request filed on March 16, 2015. RVCM requests an eighth extension of the STA granted on November 2, 2009, to operate Station WVZN with temporary facilities due to loss of the licensed site in 2007.¹ In support of the request, RVCM stated that it plans to submit an amendment to its pending application (BP-20140425AAA) before June, which should allow for a subsequent grant.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WVZN may continue to operate with the following facilities:

Geographic coordinates 40° 01' 28" N, 76° 28' 31" W (NAD 1927)


¹ WVZN is licensed for ND operation on 1580 kHz with 0.5 kW day and 0.005 kW night.

Frequency	1580 KHz
Hours of operation	Unlimited
Operating power	Not to exceed 0.5 kW daytime, 0.005 kW nighttime
Antenna type	long wire
Overall height	9.1 meters (30')

It will be necessary to further reduce power or cease operation if complaints of interference are received. RVCM must notify the Commission when licensed operation is restored.² RVCM must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. We anticipate that RVCM will file an acceptable amendment to BP-20140425AAA before June 2015 so that the application can be granted, which will then allow RVCM to file an FCC Form 302 license application in order to resume licensed operations.

This authority expires on **October 13, 2015**.
