Dear Mr. Lipp:

This is in reference to the request filed on March 17, 2014. RLHC requests an extension of the STA granted on August 22, 2013, to operate station KKAT(AM) with reduced power using the nighttime transmitter during daytime hours due to damage to the daytime transmitter.¹ In support of the request, RLHC states that additional time is requested to allow for final action on the AM Revitalization proceeding (MB Docket 13-249), so that an FCC Form 301 application can be filed to modify the facility (or to repair the daytime transmitter).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED. Station

¹ KKAT(AM) is licensed for ND operation on 860 kHz with 10 kW (D), 3 kW (CH), and 0.196 kW(N).

KKAT(AM) may continue to operate with reduced power. RLHC must file an FCC Form 301 application to modify the licensed facility when the MB Docket 13-249 has been adopted, or replace the daytime transmitter (if unable to repair), and then notify the Commission when licensed operation is restored.² RLHC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 15, 2015**.
