MOTION FOR EXTENSION OF TIME

Bernard Dallas LLC (“Bernard”), by its attorney, hereby requests an extension of time to file its Opposition to the Petition to Deny filed by David A. Schum, Pro Se (“Schum”). In support of its position, the following is stated:

On April 8, 2015, Bernard filed an application to assign the licenses of AM Stations KFCD, Farmersville, Texas and KHSE, Wylie, Texas to ACM Dallas V LLC. On May 12, 2015, Schum filed a Petition to Deny against the assignment application. The Petition to Deny is 31 pages in length and contains 15 Exhibits, totaling approximately 140 pages.

Under the Commission’s rules, an Opposition to the Schum Petition to Deny would be due on May 22, 2015. However, while Schum emailed the Petition to Deny to counsel for
