## Dear Licensee:

This is in reference to the request filed May 20, 2015, on behalf of St. Francis High School of Mountain View ("St. Francis HS"). St. Francis HS requests a second extension of the May 15, 2014 special temporary authority ("STA") to permit continued operation of station KSFH at reduced power and a slightly changed transmitter site, until construction permit application BPED-20150219ABM can be processed, granted, and implemented.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We find that extension of STA is warranted, and the extension IS HEREBY GRANTED. Accordingly, KSFH may continue to operate with the following temporary facilities:

Geographic coordinates: 37° 22′ 7.4″ N, 122° 05′ 5.65″ W (NAD 27)

Channel 200D (87.9 MHz)

Effective radiated power: 0.0066 kilowatts (H & V only)

Antenna height:

above ground: 9 meters

above mean sea level: 57 meters (Corrected) above average terrain: -108 meters (Corrected)

Site elevation: 48 meters

Supporting Structure Height: 9 meters above ground level

Transmitter Power output (TPO): 0.0185 kW (the 0.010 kW TPO limit in Section 73.506(a)

is waived)

KSFH must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on November 17, 2015. Any requests for further extension of this STA must include a statement summarizing the efforts made by the licensee during the most recent STA period, toward implementing permanent facilities.
