Dear Licensee:

This is with respect to the petition for reconsideration ("Petition") filed on March 12, 2015, by Guenter Marksteiner ("Licensee"), the licensee of WHDN-CA, Naples, Florida ("Station").<sup>1</sup> In a letter dated February 11, 2015,<sup>2</sup> the Station's license was canceled pursuant to Section 312(g) of the Communications Act of 1934, as amended ("Act"),<sup>3</sup> for failing to transmit a broadcast signal for twelve consecutive months. At the time of cancellation Commission records indicated that the Station had been silent since January 6, 2014. For the foregoing reasons, we grant the Petition and reinstate the above captioned license, call sign, and digital construction permit.

The Petition states that the Licensee was not silent for twelve consecutive months and transmitted a broadcast signal from May 31, 2014 to June 1, 2014. The Licensee states that it was unable to maintain operation due to technical issues with its analog transmitter. Attempts to repair the transmitter and keep the Station operating beyond June 1, 2014 were unsuccessful and the Station was again forced to go silent. On April 16, 2015, the Division sent a letter to the Licensee requesting additional information about the Station's purported operation in order to ensure that its operation was consistent with the requirements of Section 312(g).<sup>4</sup> The Licensee responded in a timely manner to all Commission requests.<sup>5</sup> Based on the evidence provided, we find that the Licensee has demonstrated that the Station transmitted a broadcast signal consistent with Section 312(g) and was not silent for twelve consecutive months. We remind the Licensee that in order to prevent automatic expiration of its license pursuant to Section 312(g) the Station must transmit a broadcast signal, consistent with Commission precedent,<sup>6</sup> no later than June 1, 2015.
