Dear Madam Secretary:

On March 12, 2012, the FCC issued to L4 Media Group, LLC ("L4 Media"), licensee of the above-captioned Class A television stations (the "Stations"), an Order to Show Cause (DA 12-384) why its authorizations should not be modified to specify the Stations as a low power television stations. L4 Media responded to the Order to Show Cause on April 13, 2012. On various dates thereafter, L4 Media filed applications for renewal of each station's license, as listed in the attached Exhibit A (collectively, the "Renewal Applications"). On November 19, 2014, L4 Media filed an application to assign the license of WZXZ-CA, Orlando, FL, to OTA Broadcasting (MCO), LLC (BALTTA- 20141119ADW) (the "Orlando Assignment Application").


By this letter, following discussions with the FCC staff regarding the unresolved Order to Show Cause, Renewal Applications and the Orlando Assignment Application, and based on assurances and representations by the Commission staff regarding the dispositions of the Stations following the FCC's receipt of this letter, L4 hereby agrees, pursuant to Section 73.6001(d) of the FCC's rules, to voluntarily downgrade the following six stations from a Class A to low power television status:

WBXG-CA, Facility Id. 70413, Gainesville, Florida  
WBXV-CA, Facility Id. 70418, Louisville, Kentucky  
WBXU-CA, Facility Id. 70424, Raleigh, North Carolina  
WBXP-CA, Facility Id. 70425, Memphis, Tennessee  
WXSX-CA, Facility Id. 70427, Savannah, Georgia  
WBXT-CA, Facility Id. 70430, Tallahassee, Florida.

L4 understands that, upon receipt of this letter, the FCC will undertake the necessary actions to effect: (i) the dismissal of the Order to Show Cause and any fines or fees outstanding or that could arise therefrom; (ii) grant of the Renewal Applications without conditions and without any fines or fees outstanding or that could arise therefrom; (iii) grant of the Orlando Assignment Application with no conditions materially adverse to L4 Media or to the assignee; and (iv) the reclassification, from Class A to low power status, of the six stations listed above.
