Dear Licensee:

This is with respect to the petition for reconsideration ("Petition") filed on March 11, 2015, and the supplement to the Petition ("Supplement") filed on April 30, 2015, by Budd Broadcasting Co., Inc. ("Licensee"), the licensee of WFXU(DT), Live Oak, Florida ("Station"). In a letter dated February 10, 2015, the Station's license was canceled pursuant to Section 312(g) of the Communications Act of 1934, as amended ("Act"), for failing to transmit a broadcast signal for twelve consecutive months. At the time of cancellation, Commission records indicated that the Station had been off the air between at least August 4, 2008 and November 15, 2009. For the foregoing reasons, we grant Licensee's Petition and reinstate the above captioned license and call sign.

The Petition states that the Licensee was not silent for twelve consecutive months and transmitted a broadcast signal during October, November and December of 2008 and August and November of 2009. The Licensee supported this statement with declarations from the Licensee's President and technical consultant, as well as electrical consumption reports. Following receipt of this Petition, the Division contacted Licensee's counsel requesting additional evidence of the Station's purported operation in order to ensure that its operation was consistent with the requirements of Section 312(g). The Licensee responded with a Supplement which included seven declarations of individuals in the Licensee's community who certify to having viewed "The Ilene Silverman Show," which was apparently broadcast on WFXU(TV) during the period in question. Based on the entirety of the evidence, we find that the Licensee has demonstrated that the Station transmitted a broadcast signal consistent with Section 312(g) and was not silent for twelve consecutive months.
