Dear Mr. Sutor:

This is in reference to the request filed on May 12, 2015. Entercom requests a second extension of the STA granted on June 24, 2014, to operate station KNSS(AM) with parameters at variance from license values and/or reduced power while maintaining monitor points within license limits due to equipment changes.¹ In support of the request, Entercom states that the FCC Form 302 application (BMML-20141014AWB) remains pending before the Commission.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KNSS(AM) may continue to operate ND daytime with up to 1.25 kW from either of the two towers in the array. Additionally, KNSS(AM) may operate ND at night with a power not to

exceed 1.25 kW from either tower, or may operate directionally using parameters determined by the submitted Method of Moments proof. It will be necessary to further reduce power or cease operation if complaints of interference are received. Entercom must notify the Commission when licensed operation is restored.² Entercom must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. we anticipate that Entercom will file a curative amendment so that a new license can be granted before the expiration date shown below.

This authority expires on **December 1, 2015**.
