Dear Sir or Madam,

I'm writing regarding the above reference file numbers and the subsequently granted FM Broadcast Station license for the call sign KZOC, Bourbon, MO. There has apparently been a filing error which inadvertently caused a Form 302 form to be mistakenly filed with the Commission for KZOC FM Bourbon, MO.

I was unaware of this error and filing until I recently received the signed hard copy of the granted FM Broadcast Station License in the mail from the Commission that was dated May 20, 2015.

I believe that this error occurred due to some internal miscommunication within our organization and I sincerely apologize for this inadvertent filing and error. Apparently, a "pro-forma" Form 302 form was prepared prior to the completion of construction in the CDBS in anticipation of the completion of the construction for KZOC FM Bourbon, MO. It appears that this "pro-forma" form was mistakenly filed in the CDBS prior to the expiration date of the KZOC Construction Permit. To be clear, it was not our intent to file this form.

A last minute issue with the tower owner regarding the NTP for the station construction prevented the tower crew from installing the antenna. Consequently, the station did not meet its construction deadline in the Modified Construction Permit File # BMPH-20150407AAB of May, 8 2015.


Therefore, ALMA Corporation respectfully requests that the inadvertent and erroneously filed form 302 application be dismissed (File# BLH-20150507ABY) by the Commission. Furthermore, ALMA Corporation hereby surrenders the mistakenly granted FM Broadcast License (BLH-20150507ABY) to the Commission and requests that it be cancelled.

In addition, ALMA Corporation also respectfully requests that the Commission also dismiss its previously filed Form 314 application (File # BAPH-20150331ARY), as this application is now moot.

I sincerely apologize for any inconvenience this filing error has caused and appreciate the Commission and staff's cooperation in satisfactorily resolving this matter.
