Dear Mr. Dickey:

This is in reference to the request filed on June 5, 2015. Cumulus requests an extension of the STA granted on December 9, 2014, to operate station WLZR(AM) with reduced power due to required equipment repairs.¹ In support of the request, Cumulus states that in the past six months, progress has been made and Cumulus plans to file an FCC Form 302 application to update all operating parameters and resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


We noted that Cumulus filed an FCC Form 302 application (BZ-20150612ABW) shortly after filing this request, and it was granted on June 25, 2015. As a result, the request for extension of STA IS HEREBY GRANTED, and station WLZR(AM) may continue to operate during daytime hours with reduced power (if needed) until a one page letter has been filed in triplicate with the Secretary's office to the attention of supervisory engineer Son Nguyen to verify licensed operations have been restored. Cumulus must use whatever means are necessary to protect workers and the public from

exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

We anticipate that the resumption letter will be filed within the next few weeks, therefore this authority expires on **August 1, 2015**.
